The Board of Directors of Seymour Pink will be offering one \$5,000.00 scholarship annually in Colleen Fries' memory to a deserving college bound student.

Applications must be received no later than Monday, April 22, 2024

In order for a student to be eligible for this scholarship, the applicant must meet the following criteria:

1. *The applicant must be a resident of Seymour, CT.*
2. *The applicant must be either a graduating high school senior that intends to pursue a degree in law, political science or social services at an accredited 2 or 4 year college, university or technical school for the 2024-2025 academic school year.*
3. *The applicant must complete the application form and write an essay in response to the following prompt: **Passion and drive are two forces that motivate people to help their community. Discuss your favorite ways to help your community in order to make a difference in the lives of others.***
4. Incomplete applications will not be considered.
